## Resolution no. 705-2021

AN ORDINANCE IMPOSING PENALTY TO ANY PERSON OR ENTITY WHO ARE SELLING COVID-19 VACCINES, OWNED OR DONATED TO THE GOVERNMENT, AND THOSE WHO PROVIDE OR PROMISE TO PROVIDE VACCINATION SLOTS OR SCHEDULES IN EXCHANGE OF VALUABLE CONSIDERATION, WITHIN THE TERRITORIAL JURISDICTION OF SAN FERNANDO, BUKIDNON

WHEREAS. The National Government establish the coronavirus disease (COVID-19) vaccination program though out the country by adopting an integrated approach to health development which shall endeavor to make essential social services available to all people pursuant to Republic Act no. 115251 series of 2020.

WHEREAS, there are person/s or groups initiating schemes to sell COVID-19 vaccines for profit, and are taking advantage of the people's desire to get vaccinated as early as possible by providing vaccination slots or schedules in exchange for money or for their personal benefit,

WHEREAS, the municipality of San Fernando is stepping up its efforts to prevent such acts of fraudent sale of COVID- 19 vaccines and vaccination slots as well congruent to the mandate of the DILG;

WHEREFORE, on motion of Hon. Antonio M. Abayato, Jr., duly seconded by Hon. Genaro P. Pacquiao, with unanimous accord of all members present be it,

RESOLVED, to pass this ordinance, thus:

## Ordinance no. 894-2021

BE IT ORDAINED, by the 14th Sangguniang Bayan of San Fernando in session assembled that:

SECTION 1. TITLE-This ordinance shall be known as an ORDINANCE IMPOSING PENALTY TO ANY PERSON OR ENTITY WHO ARE SELLING COVID- 19 VACCINES, OWNED OR DONATED TO THE GOVERNMENT, AND THOSE WHO PROVIDE AND PROMISE TO PROVIDE VACCINATION SLOTS OR SCHEDULES IN EXCHANGE OF VALUABLE CONSIDERATION, WITHIN THE TERRITORIAL JURISDICTION OF SAN FERNANDO, BUKIDNON

SECTION 2. DEFINITION- Whenever used in this Ordinance, the following terms shall be construed to mean as follows:

- a) Vaccines- includes any brand of Covid-19 vaccine
- b) Valuable consideration= includes money or any kind of benefit conferred by an individual or party in exchange for a vaccination slot or schedule.



## SECTION 3. PROHIBITIONS-

- No person or entity within the municipality of San Fernando is allowed to sell vaccines, of which
  are owned or donated by the government.
- 2. It shall be unlawful to any person or entity to collect money or any benefit or consideration in favor of vaccination slots or schedule of vaccination within the municipality of San Fernando Bukidnon

SECTION 4. PENALTY- Any person violating this ordinance shall be subject to a penalty of P2,500.00

SECTION 5. SEPARABILITY CLAUSE- for any reason, or reasons any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provision hereof, which are not affected thereby shall continue to be in full force and effect

SECTION 6. REPEALING CLAUSE- all ordinances, rules and regulations in conflict with the provision of this ordinance are hereby repealed or amended accordingly.

SECTION 7. EFFECTIVITY CLAUSE- this ordinance shall take effect upon its approval

RESOLVED FURTHER, to furnish copy of this resolution to agencies concern for their information, action and support.
