**Resolution No. 794-2022**

**RESOLUTION ENACTING AN ORDINANCE PROHIBITING THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (LDRRMO) IN TRANSPORTING FROM AND TO, OR RESPONDING TO NON-EMERGENCY CASES OR THAT IS NOT REQUIRED IMMEDIATE ACTION ESPECIALLY PREGNANT CASE, IN THIS MUNICIPALITY.**

**WHEREAS**, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, pregnancy and childbirth are among the leading causes of death, disease, and disability in women reproductive age in developing countries; that every year, around 2000 mothers die due to pregnancy-related complications;

**WHEREAS**, LDRRMO shall take into consideration in any case of difficult situations and complications among pregnant women upon the recommendation of the Midwife, Health Worker in their jurisdiction.

**WHEREFORE**, on motion of Hon. Antonio M. Abayato duly seconded by Hon. Juan A. Sambalud, with unanimous accord of all members present, be it;

RESOLVED, to enact this ordinance, thus;

**ORDINANCE NO. 908-2022**

BE IT ORDAINED by the 14<sup>th</sup> Sangguniang Bayan of San Fernando, Bukidnon, in session assembled, that;

**SECTION I-** this Ordinance is to prohibit the Local Disaster Risk Reduction and Management Office (LDRRMO) in transporting from and to or responding to non-emergency cases or that is not required immediate action, especially for pregnant cases.

**SECTION II-** the prohibition of responding pregnant cases is to prioritize in the event of emergency in our Municipality.

**SECTION III-** LDRRMO shall be responsive in any case of demanding circumstances and complications among pregnant women and if the client/patient is about to give birth.


**SECTION IV-** this ordinance shall take effect immediately upon approval.
