A RESOLUTION OF BIDS AND AWARDS COMMITTEE (BAC) DECLARING **CENTRO SUPERSALES, INCORPORATED** AS A SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING TO AWARD THE BIDDING FOR THE PROCUREMENT OF **SUPPLY AND DELIVERY OF FUEL FOR VARIOUS VEHICLE AND HEAVY EQUIPMENT** WITH THE CONTRACT PRICE OF FOUR MILLION THREE HUNDRED TWENTY NINE THOUSAND FOUR HUNDRED FIFTY NINE PESOS AND FIFTY CENTAVOS (PHP4,329,459.50).

**BAC RESOLUTION NO. 05, Series of 2023**

*Whereas*, on **February 14, 2023** the Bids and Awards Committee, of the Municipality of San Fernando, Bukidnon, advertised the Invitation to Apply and to Bid of the **Supply and Delivery of Fuel for Various Vehicle and Heavy Equipmen** posted in the PhilGEPS and likewise in the three (3) conspicuous places of the municipal premises intended for the purpose from **February 14, 2023 to March 3, 2023** as stipulated in the 2016 IRR of 9184;

*Whereas*, in response to the said advertisement, **only one** supplier submitted a letter of intent and application for eligibility;

*Whereas*, on **March 6, 2023 @ 10:00 O' clock** in the morning, The BAC members, together with the BAC Technical Working Group (BAC-TWG) and the BAC- Secretariat convened for the opening of bid documents submitted for the procurement of **Supply and Delivery of Fuel for Various Vehicle and Heavy Equipmen**;

*Whereas*, Section 36. Paragraph (a) of the 2016 IRR of 9184) If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;

*Whereas*, the bid proposals of the following bidder was found to be substantially complying:




