WHEREAS, the Local Government Unit of San Fernando, Bukidnon, advertised the Invitation to Apply for Eligibility and to Bid of the **Supply and Delivery of Food Commodities** posted in PhilGEPS and the same in the three (3) conspicuous places at the premises of the Local Government Unit of San Fernando, Bukidnon continuously for **twenty (20)** Calendar days as what stipulated in section 21.2 of the 2016 IRR of 9184;

WHEREAS, in response to the said advertisement, two bidders submitted letters of intent and application for eligibility;

WHEREAS, on **March 6, 2023 @ 10 O' clock** in the morning the Bids and Awards Committee (BAC), BAC-TWG and the BAC secretariat convened for bid opening of Technical and Financial Documents submitted by the bidders for procurement of **Supply and Delivery of Food Commodities**.

WHEREAS, upon careful examination and evaluation of the BAC members and Technical Working Group (TWG) of Technical Documents found out that the two bidders were found illegible;

WHEREAS, the bid proposals of the following bidders were found to be substantially complying;


